 - (i) For the posts at **Part-A** Sr. No. 1 to 9, the selected candidates are required to be stationed at Sugarfed Head Quarter, Mohali.
 - (ii) For the posts at **Part-B** Sr. No. 1 to 12, the selected candidates are required to be stationed at various units/Cooperative Sugar Mills of Punjab *State* Federation of Cooperative Sugar Mills Ltd. However, he/she can be transferred at any other place /anywhere at the discretion of the management.
 - (iii) For the posts at **Part C** Sr. No. 1 to 5 (Ajnala CSM), Sr. No. 1 to 3 (Budhewal CSM), Sr. No. 1 to 7 (Batala CSM), Sr. No. 1 to 8 (Bhogpur CSM), Sr. No. 1 to 5 (Fazilka CSM), Sr. No. 1 to 3 (Gurdaspur CSM), Sr. No. 1 to 3 (Morinda CSM), Sr. No. 1 to 5 (Nakodar CSM) and Sr. No. 1 to 5 (Nawanshahr CSM), the selected candidate are required to be stationed at various units/Cooperative Sugar Mills of Punjab *State* Federation of Cooperative Sugar Mills Ltd.
- 1.4 The applicant who has given/taken dowry is not entitled for appointment. The candidate if married is required to submit an affidavit in prescribed format that he has not given/taken dowry. The affidavit will be submitted by the selected candidate within 15 days of receipt of information regarding selection.

2. Pay Pattern and Other Benefits:-

- 2.1 Level of Pay scale is mentioned against the Post. The pay pattern as applicable in the Sugarfed, Punjab is prescribed against each vacancy which is subject to final approval of Govt. of Punjab, Department of Finance. This Level of Pay scale may either increase or decrease.
- 2.2 <u>Gratuity as per payment of Gratuity Act and Provident Fund as per Provident Fund Act.</u>

3. Age Limit:-

- For the posts mentioned in Part A, B and C- Age of candidate belonging to any category should not be less than 18 years as per concerned service Rules.
- For the posts mentioned in Part A and B- Upper age limit of General Category candidate should not be more than 37 years as per concerned service Rules.
 - For the posts mentioned in Part C- Upper age limit of General Category candidate should not be more than 45 years as per Mill's cadre service Rules.
- For the posts mentioned in Part A and B- Maximum upper age limit of Schedule Caste and Backward Class candidates residing in the State of Punjab will be 40 years.
- For the posts mentioned in Part A and B- Maximum age limit while giving relaxation in the upper age limit for the employees of State and Central Government will be 40 years.

- ➤ For the posts mentioned in Part A, B and C In the case of Ex-servicemen residing in the State of Punjab, the upper age limit will be according to the amendments made from time to time in the Punjab Recruitment of Ex- servicemen Rules 1982. This upper age limit is the remaining age after deducting the period of service in the army from his age. If the remaining age does not exceed the upper age limit of the post by more than 3 years as per the service rules, then he will be considered to have fulfilled the conditions of the upper age limit.
- For the posts mentioned in Part A and B- Maximum upper age limit for handicapped persons residing in the State of Punjab will be 45 years.
- For the posts mentioned in Part A and B-The upper age limit for widows, divorcees and certain other categories of married women as per instructions issued by the Government of Punjab vide letter No.1/50/83-5PP(1368)/3454dated 23.04.1984 will be relaxed upto 40 years.
- ➢ Govt. servants must submit their applications online by the prescribed date. However, they will be considered for selection only if their applications are received through proper channel with "No objection certificate" from the concerned department is furnished on or before the selection process.
- 4. **Qualification:**-Educational Qualification and Required experience is indicated against each post. The Qualification of Punjabi upto Matric Standard for direct recruitment shall be essential. However, the candidates who have not passed Punjabi upto Matric Standard shall be allowed to appear for the Examination without the pre condition of having passed Punjabi Language upto Matriculation level but it would be mandatory for such candidates to clear Punjabi language test during the probation period of three years. During the probation of three years, the selected candidate will be paid only minimum basic pay as per 7th CPC. The applicant must have acquired the prescribed degree on REGULAR BASIS only from a recognised Board/University.
- 5. Reservation:-The application of reservation is indicated specifically against each post. Reservation which includes women reservation also shall be as per policy / instructions of the Govt. of Punjab. It shall include the candidates of:-SC/ST/BC/Physically handicapped /Ex-Serviceman/Lineal Descendents of Ex-Serviceman/Wards of Freedom Fighter and Sports person. Sports person seeking reservation under sports quota should apply with sports gradation certificate issued by Director Sports, Punjab as per latest instructions of Govt. of Punjab. The applicants including women reservation of SC/ST/BC/Physically handicapped /Ex-Serviceman/Lineal Descendents of Ex-Serviceman/Wards of Freedom Fighter and Sports person category of States, other than Punjab will be considered under Un-Reserved (UR) category.

6. Mode of Selection:

Written Test, however the management may adopt any other appropriate methodology for short listing of candidates for all the posts.

7. <u>Details of Written test for the posts</u> -

7.1 The selection for the post will be on the basis of merit in the Written Test. *In the case of two or more candidates obtaining equal marks in the written test, the candidate older in age shall be placed higher in the order of merit.*

7.2 The question paper will be of Total 100 Marks of 02 hours. There will be 100 MCQ (Multiple Choice Question) type questions of one mark each. The pattern of Question paper will be as follow:
